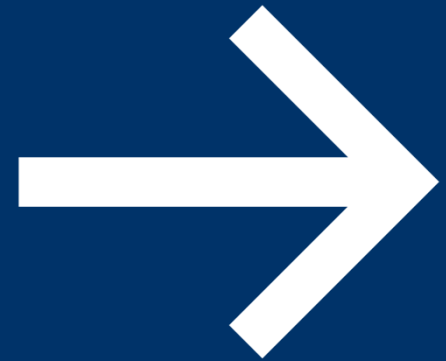
Meeting Minutes – Secretary Report

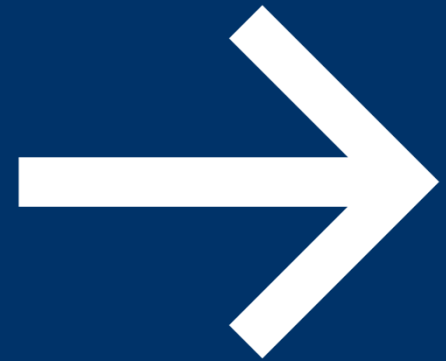

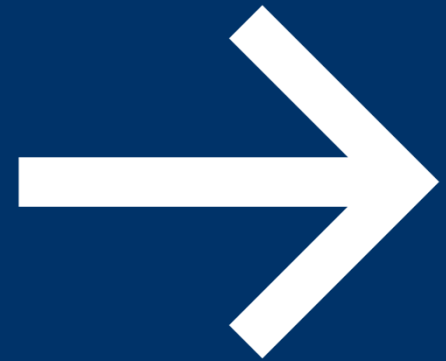
